Definitions and interpretation

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Ali Ghassemi trading as Ouzaria Ltd. and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Ali Ghassemi trading as Ouzaria Ltd. is the "data controller". This means that Ali Ghassemi trading as Ouzaria Ltd. determines the purposes for which, and the manner in which, your Data is processed.

Data collected

- 5. We may collect the following Data, which includes personal Data, from you:

in each case, in accordance with this privacy policy.

How we collect Data

- 6. We collect Data in the following ways:

Data that is given to us by you

- 7. Ali Ghassemi trading as Ouzaria Ltd. will collect your Data in a number of ways, for example:

Data that is collected automatically

 - c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology.

Your rights
